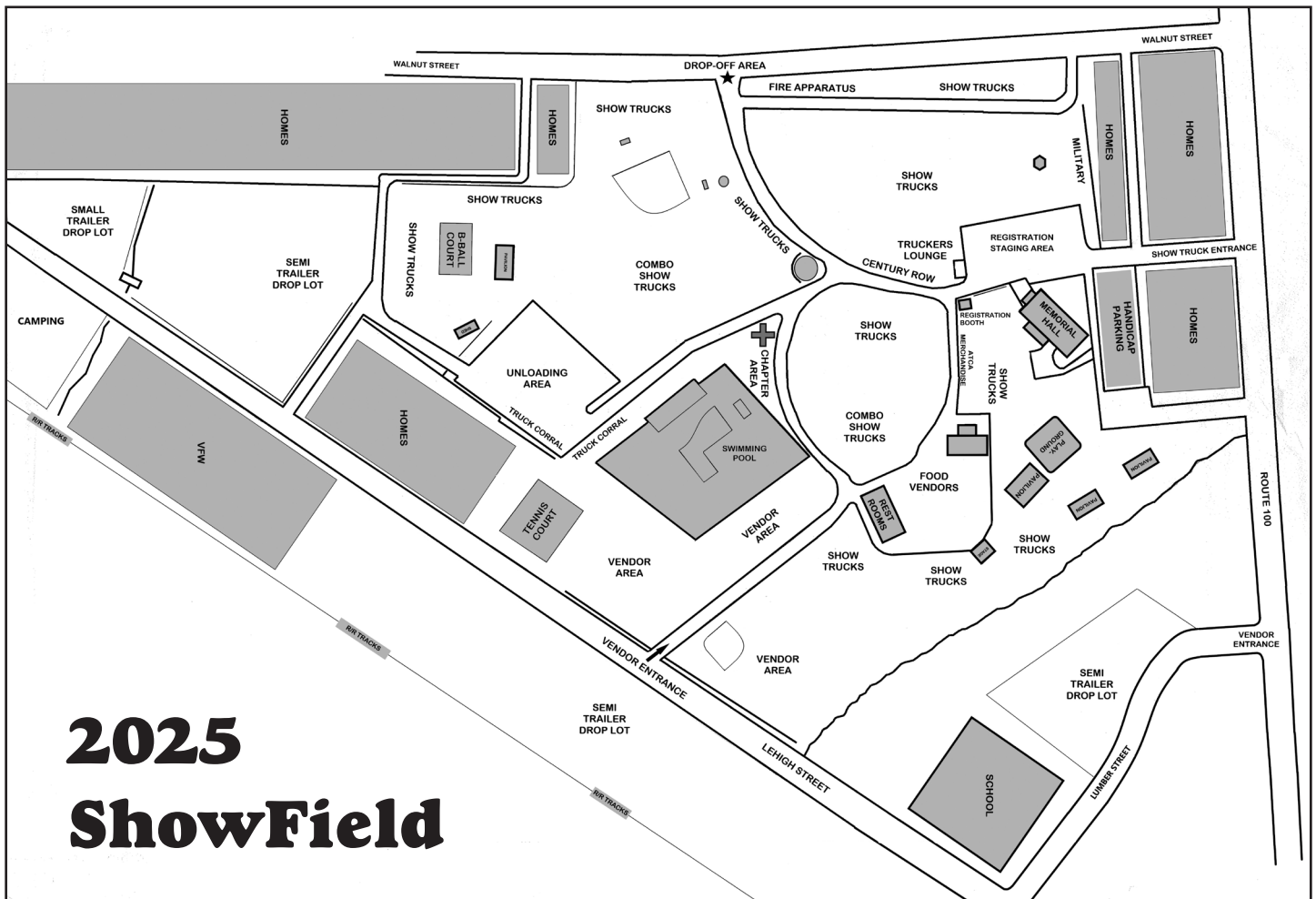

# 2025 SHOW REGULATIONS

## Show Vehicle Regulations for all ATCA Events

- All exhibited vehicles must be equipped with a working fire extinguisher.
- Exhibitors must have all vehicles secured by a working parking brake or wheel chocks.
- Show trucks must be at least 25 years old (1999 or older) to park on the show field.
- Any truck that is modified, or a show truck less than 25 years old (2000 or newer) must be approved by the show committee. A photo must be provided review and consideration.

- Show trailers must be at least 25 years old (2000 or older) to park on the show field.
- Any trailer that is modified or a show trailer less than 25 years old (2001 or newer) must be approved by the show committee. A photo must be provided review and consideration.

- Every vehicle, including trailers, must be covered by the owner's liability Insurance. The exception will be non-operational vehicles brought in on and NOT removed from trucks and/or trailers.
- Fuel tanks must be capped. Fuel leaks are grounds for refusing entry to the show, or removal by towing. Towing and clean-up of fuel or oil spills will be at the vehicle owner's expense.
- Truck Corral vehicles must be operational or remain on a trailer during the event.

## Parking Regulations for all ATCA Events

- Show truck parking will begin Thursday afternoon, June 13, 2024.  
*No trucks are allowed on show field prior to that time.*
- Show vehicles are to be escorted by an official parking staff volunteer on a golf cart. This includes trucks entering from the unloading area.
- Show truck parking will be done in the order in which you arrive. If you want to park by a friend, arrive together. No spaces will be held for late arrivals.
- Each vehicle will be taken to its designated display area and is then requested to remain in place for the duration of the show, except to participate in an event or to be moved as required or permitted by the show management.
- Show trucks should remain parked on the show field until 4:00pm Friday and Saturday of the show.

## Golf Cart and Personal Mobility (NO ATV/UTV) Vehicle Regulations for all ATCA Events

- Any personal mobility vehicle that is not an electric mobility device or a standard golf cart must be approved by the show committee. A photo must be provided for review and consideration. Email to: atcanationalmeet@gmail.com
- Motorized golf carts and personal mobility vehicles must be insured and registered with a cell phone number on record at the registration booth.
- Only licensed drivers are permitted to operate golf carts.
- The ATCA Show Committee restricts operation of golf carts during increased spectator traffic hours including but not limited to 10 a.m. to 2 p.m. on Saturday. Additional restrictions may be announced during the show.

## General Regulations for all ATCA Events

- NO alcoholic beverages are allowed on the show grounds during show hours.
- All vehicles are to be operated in a safe courteous manner and must be in safe working order.
- At events where pets are allowed, they are to be leashed, and remain under the constant control of their owners. The pet owner is solely responsible for the actions of the pet.
- Activities not associated with the antique truck hobby such as moon bounces, trampolines, drone activities, helicopter, and balloon rides, etc. are prohibited.
- The show management reserves the right at its sole discretion to deny admission to any person or vehicle, or to require any person or vehicle to leave, without refunding the registration fees.
